He also was active in the San Diego community, serving as a coach, mentor, arbitrator, settlement officer and Judge Pro Tem.

He has extensive experience in dealing with veterans and veterans' issues, having served in the Marine Corps Reserve for 28 years in various roles, including as a judge advocate. He is passionate about helping service members and veterans better understand the justice system.

While on the bench, Comm. Armento was appointed to several leadership positions with prominent statewide committees, including the Civil Litigation and Restraining Order committees. He has also been extensively involved with the American Inns of Court, having served as a Judicial Master with his Inn since 2009.
