**RATES:**

**Superior Court Ordered Civil Mediations:**

- Civil Limited: \$150 per hour for each of the first two hours and \$525 per hour thereafter. Cases with three or more parties will be billed thereafter at the hourly rate of \$575.
- Civil Unlimited: \$250 per hour for each of the first two hours and \$525 per hour thereafter. Cases with three or more parties will be billed thereafter at the hourly rate of \$575.

### **Private Mediations:**

- \$525 per hour in session (full day, half day, and three-quarters of a day available at proportionate rate; plus two hours brief review at \$525.
- All cases with three or more parties will be billed at the hourly rate of \$575.
- \$400 non-refundable per party administrative fee
