Superior Court-Ordered Civil Mediations:

- Civil Limited: \$150 per hour for each of the first two hours; \$650 per hour thereafter.
- Civil Unlimited: \$250 per hour for each of the first two hours; \$650 per hour thereafter.
- Pre-mediation calls at no charge

HOA Pre-litigation Matters:

- \$1,000 flat rate for up to 3 hours + \$650 per hour thereafter.
- \$650 per hour for brief review.
- \$250 per party administrative fee

- Half day - \$3,250 flat rate: includes preparation, pre-mediation conference, and 4 hours of mediation time; \$650 per hour thereafter, in 1/2 hour increments
- Full day - \$6,500 flat rate: includes preparation, pre-mediation conference, and 8 hours of mediation time; \$650 per hour thereafter, in 1/2 hour increments.
- \$450 non-refundable administrative fee per party
- Pre-mediation calls at no charge
